MINUTES - MAY 12, 2021 COUNCIL MEETING

A meeting of the Council of the Delaware Association of Professional Engineers was held on Wednesday May 12, 2021 via teleconference at 3:00 p.m.

The Roll call was taken and a quorum was declared.

Meeting was called to order at 3:06 PM.

Open Forum

Two members of the public were present and introduced themselves:

- M Davis provided a brief update of the status of HB 142, which is expected to pass the House on a consent agenda in the next week or so. C. Balascio participated in the House Committee hearing, and will speak on DAPE's behalf at the Senate Committee hearing as well. She has contacted the Governor's office regarding the Sussex County appointed seat that will be open this year.
- N. Batta has expressed interest in running for the open Chemical Engineering seat, so participated in this meeting as an observer to understand the role better.

Minutes of the April 14, 2021 Council Meeting

Council reviewed the Minutes of the April 14, 2021 Council meeting.

Motion by M. Clendaniel, seconded by C. McAllister, to approve the minutes of the April 14, 2021 meeting. Approved unanimously.

D.A.G. Report

Conflict of Interest disclosure: DAG Kelly drafted this drawing details from the DAPE bylaws and State Code of Conduct. Motion by D. Barbato to approve Conflict of Interest Policy, seconded by

M. Clendaniel. After further discussion, Council requested that DAG Kelly redraft, with the policy and disclosure form separated into two distinct documents. The policy would be added to our website, and shared with Council members each September at the annual meeting. Council members will be encouraged to disclose potential conflicts as needed. Motion withdrawn by D. Barbato without objection.

Financial Reports

M. Clendaniel summarized DAPE's finances for the twelve months (100%) of fiscal year ending April 30, 2021, which reflect income has reached 98.4% of projections and expenses 74.9%. J. Wootten has scheduled our bookkeeper for bank reconciliation, then will reach out to auditors.

Motion by M. Clendaniel, seconded by C. McAllister, Council accepts the Finance Report subject to audit. Approved unanimously.

Committee Reports

Executive Committee

The Executive Committee met just prior to the Council meeting, therefore, a written report is unavailable. Items discussed at Executive Committee meeting will be covered under the appropriate Committee reports.

Finance/Employee Compensation & Benefits Committee/Facilities Committee - No Report

Law Enforcement/Ethics Committee

C. McAllister reported that the committee met on May 5, 2021 and discussed the following:

- A plan to draft proposed legislative amendment language to define negligence and gross negligence clearly
- Draft committee guidelines
- NCEES announced Law Enforcement training that is typically offered during the annual meeting will be scheduled for June 15-16. J. Wootten will share details with all committee members.
- Will recommend closure of 10 files
- Recommends approval of 1 PE application which were referred by Examining Committee

Motion by C. McAllister, seconded by D. Reinhold, Council approves the closure of 10 files as listed on Exhibit A of the Committee's report. Approved unanimously.

Examining Committee

K. Tadler reported that the Committee met on March 31, 2021, and discussed the following:

- Draft Committee Guidelines
- Proposed CPC Guidelines Revisions
- HB 142 Status
- April 2021 PE Exam report
- Plan to train committee members on Certificate of Authorization review at May meeting.

The Committee reviewed 38 individual applications for licensure and confidential recommendations were made for Council action at their meeting May 11, 2021 consisting of 36 applications for comity (34 recommended for license approval, 1 backlogged pending further review, 1 referred to LEE Committee and now recommended for approval), and 2 applications for examination (both recommended for approval to take the PE exam). All recommendations for licensure or approval to take the P&PE exam are shown on Exhibit A1 which is now ready for Council action.

One applicant has met all requirements for licensure after successful passage of a computer-based P&PE exam. Recommendations for licensure are shown on Exhibit A2.

Motion by K. Tadler, seconded by K. Maxson, Council approves the Committee's recommendations for applications for licensure as noted on Exhibits A1 and A2 of the committee's report. Approved unanimously.

The Committee also reviewed 12 applications for Certificate of Authorization and 4 applications for Certificate of Authorization Reinstatement. Committee recommendations are noted on Exhibit A3.

Motion by K. Tadler, seconded by K. Maxson, Council approves the Committee's recommendations for Certificates of Authorization as noted on Exhibit A3 of the committee's report. Approved unanimously.

The backlog of applications (which the Committee has reviewed but are not ready for Council action) is shown on Exhibit B.

Note: October 2021 PE exam is scheduled for 2 days.

External Affairs/Public Information Joint Committee

Committees met on May 6, 2021 to finalize plans for May 18, 2021 Forum regarding overlapping practice issues with Professional Land Surveyor Board.
