Financial Report

Law Enforcement/Ethics Committee

Executive Committee reviewed the report of the committee's meeting on August 3, 2011.

- <u>Case closures</u> -- 21 cases recommended for closure. Motion by McAllister, seconded by Robertson, Council approve the closure of the 21 cases listed on Exhibits A1-A2 of the report dated August 5, 2011. Approved unanimously.
- <u>Subpoena requests</u> Motion by McAllister, seconded by Robertson, Council issue a subpoena in **Case 11/139** for a pending investigation. Approved unanimously.

Motion by McAllister, seconded by Robertson, Council issue a subpoena in **Case 10/004** for the hearing scheduled for 8/31/11. (Council members were reminded there can be no discussion among Council members on pending cases.) Approved unanimously.

Examining Committee

The Executive Committee reviewed the report of the Examining Committee's meeting of July 27, 2011. Forty-two (42) individual applications for licensure were reviewed and confidential recommendations made for Council action consisting of **27** applications for **comity**; and **15** applications for **examination**. The Committee also reviewed **12** applications for **Certificate of Authorization**; **1** request for **Temporary Permit**; and **2** requests for Reinstatement of licenses.

Motion by Shine, seconded by Newton, Council approve the recommendations of the Examining Committee as shown on Exhibits A1-A3 of the report dated July 29, 2011.
