MINUTES - COUNCIL MEETING, JANUARY 11, 2012

A meeting of the Council of the Delaware Association of Professional Engineers was held on Wednesday, January 11, 2012, in the DAPE offices, New Castle, Delaware.

President McAllister convened the meeting at 3:05 p.m.

Executive Director Abshagen took the Roll call and declared a quorum was present.

Open Forum -- No members of the public present.

Minutes of the December 14, 2011 Council Meeting

Council reviewed the Minutes of the December 14, 2011 Council meeting. Council member Medlarz requested the Minutes reflect under the discussion of payment to the EPA, that upon receipt of the requested supporting documentation, payment should be made in accordance with the contract.

Motion by Newton, seconded by Kooker, Council approve the Minutes of the December 14, 2011 Council meeting as amended. Approved unanimously.

D.A.G. Report

- <u>University Consulting Engineers</u> Attorneys have agreed to an extension to 1/18/12 for the filing of briefs.
- <u>Draft Hearing Procedure guidelines</u> are a work-in-progress.
- If the <u>Educational forum</u> for Council and Committee members is to include a de-briefing of Case 10/004, this forum will need to be scheduled sometime within the next six months to provide sufficient time to conclude the case. The LE/E Committee's new DAG, Peter Jamison should be invited to participate.
- APEX Letter regarding the need to obtain a Certificate of Authorization for the Board of Surveyors --DAG Hickey has reviewed the surveyors' statute, along with the 1982 legal opinion on engineers providing surveying, and indicates in her draft response that the legal opinion is still valid and that after checking with the Surveyors' Board, it has been confirmed an engineering firm holding a Certificate of Authorization with DAPE is not required to obtain a Certificate of Authorization with the Board of Surveyors. This response will be provided to Apex Engineering.

Committee Reports

Executive Committee

The Executive Committee met just prior to the Council meeting, therefore, a written report is unavailable. Items discussed at Executive Committee meeting will be covered under the appropriate Committee reports.

Financial Report

Committee will convene a meeting in February to discuss a draft budget, employee status, financial impact of investigative services, etc.

<u>Income/expense activity</u> -- The first eight months of the fiscal year reflects income at 59% and expenses at 61% of projections.

Employee Benefits & Compensation -- No report.

Law Enforcement/Ethics Committee

Chair Kooker presented the report of the committee's meeting on January 4, 2012.

- DAG Peter Jamison has replaced DAG Andrew Kerber on the LE/E Committee. Jamison's background includes litigation experience.
- Significant discussion concerned the invoicing of the EPA. The Committee agrees the contractual arrangement requires modification and a cap for future costs. Committee member Diaz will be contacted to determine the remaining work for Case 10/004 that directly requires F. Schmitt, to get additional monies approved.
- <u>Case closures</u> -- 46 cases recommended for closure. Motion by Kooker, seconded by Shine, Council
 approve the 46 cases recommended for closure on Exhibit A of the committee's report. Approved
 unanimously.
- <u>Case 10/087</u> Consent Agreement draft was provided and revisions recommended.

Examining Committee

Co-Chair Shine presented the report of the Examining Committee's meeting of January 5, 2012. One hundred nineteen (119) individual applications for licensure were reviewed and confidential recommendations made for Council action consisting of **31** applications for **comity**; **19** applications for **examination**; and **69** applicants that now meet all requirements for licensure after successful passage of the October, 2011 exam, as shown on Exhibits A1-A4 of the committee's report dated 1/6/12.

Motion by Shine, seconded by Kooker, Council approve the Committee's recommendations as shown on Exhibits A1 – A4 of the committee's report. Approved unanimously.

The Committee also reviewed 6 applications for **Certificate of Authorization**; 4 applications for **Temporary Permit**; and 2 requests for **Reinstatement**.

Motion by Shine, seconded by Kooker, Council approve the Committee's recommendations as shown on Exhibit A5 of the committee's report. Approved unanimously.

The Committee is also reviewing its guidelines for those applicants that fail the PE exam four times and are required to reapply for future exams, in addition to providing additional education and/or experience to correct deficiencies, to insure uniformity for applicants.

The Joint Advisory Committee (JAC) is meeting on January 24, 2012.

Facilities Committee -- No report.

Public Information -- Winter issue of the newsletter due in January.

Government Affairs/By-laws Committee

Computer-based testing (CBT) language is ready, but since there are other details yet to be worked out by NCEES and we have more than a year to get this accomplished, this will be put on hold for any additions needed.

Chair Newton and committee member Medlarz will meet to discuss the necessity of this manual since many of the policies/procedures are addressed elsewhere. Report to be provided next month.
