D.A.G. Report

<u>HVACR Overlapping Practice</u> – The HVACR statute permits design, which overlaps with the responsibility of the engineer. The question is what kind of design can an HVACR do – it doesn't appear to be limited to residential or light commercial, etc. DAG Hickey is following up with the DAG of the HVAC board.

<u>Rule to Show Cause Hearings</u> – DAG Hickey reminded Council that as a result of no response to our CPC audits, on November 15, 2016 sixteen hearings took place, attended by 3 individuals to offer testimony on their behalf. - DNREC-Class B designs for lift stations -- MOU still under review by DNREC
- <u>Code of Ethics</u> Proposed revisions have been tabled until the conclusion of the governor's Licensing Review Committee's final report.
- California board shared info on Google's Certified Professional Data Engineer program to determine other states' concern with this issue. Forwarded to DAG Jarosz for comment.

Committee is recommending closure of 4 cases.

Motion by Tracey, seconded by Hayden, Council approve the closure of the 4 cases listed on Exhibit A of the committee's report. Approved unanimously.

Examining Committee

Chair Lester reported on the committee's meeting of January 5, 2017. One hundred seventeen (117) applications for licensure, including 42 for **comity**; 52 applications for those successfully **passing** the October 28, 2016 exam; and 23 applications for **examination** were reviewed. Committee also reviewed 7 applications for **Certificates of Authorization**; and 7 applications for **Reinstatement of Certificate of Authorization**.

Motion by Lester, seconded by Gharebaghi, Council approve the applications for licensure as listed on Exhibits A1-A5 of the Committee's report. Approved unanimously.

Government Affairs/By-laws Committee

Several proposed law revisions have been discussed during the past year. These include:

- ✓ Section 2806(f)(3) to reduce the number of years from 10 to 4 that a license may remain "Inactive"
- ✓ Section 2816 update to indicate the Code of Ethics is available on the DAPE website (vs. shall be provided free of charge or sent to applicants)
- ✓ Section 2820 Temporary permit issued contingent upon application for permanent licensure
- ✓ Section 2929 electronic signature in compliance with Delaware law permissible; eliminate need for embossed (vs. rubber stamp) seal to complete registration requirements
- ✓ New/disciplinary action Add voluntary surrender of a license to avoid disciplinary action by another jurisdiction is grounds for disciplinary action

The consensus of Council was in favor of these proposed revisions. Language to be drafted for further consideration.

Winter issue of the newsletter is under discussion.

Correspondence

- Maryland board member David Mongan has sent a letter seeking support for his candidacy for NCEES Treasurer during the 2017 NE zone meeting.
- S. Gharebaghi reported on his communication with an FE who although passed the exam in 2012, didn't provide the appropriate documentation for certification until 2015, which is now causing issue with the PA board where he wants to take the PE exam. Council advised this matter is closed.
