#### Minutes of the February 6, 2012 Council Meeting

Council reviewed the Minutes of the February 6, 2012 Council meeting. Motion by Newton, seconded by Robertson, Council approve the Minutes of the February 6, 2012 Council meeting as submitted. Approved unanimously.

#### D.A.G. Report

- <u>DNREC</u> proposed response for request for advisory opinion drafted indicating DAPE Council does not provide such advisory opinions. DAG Hickey to sign and send this response upon Council's approval.

# **Committee Reports**

### **Executive Committee**

The Executive Committee met just prior to the Council meeting, therefore, a written report is unavailable. Items discussed at Executive Committee meeting will be covered under the appropriate Committee reports.

### Financial Report

<u>Income/expense activity</u> -- The first ten months of the fiscal year reflects income at 73% and expenses at 85% of projections. Motion by Medlarz, seconded by Tracey, report be approved subject to audit. Approved unanimously.

The Finance Committee has scheduled a meeting on 3/20/12 to discuss 2012/2013 preliminary budget, employees' status, employee benefits, etc. Committee will also discuss a payroll service, and a budget line item for expert witness testimony.

#### Law Enforcement/Ethics Committee

Co-Chair Crouch presented the report of the committee's meeting on March 7, 2012.

- Case closures -- 2 cases are recommended for closure.

Motion by Crouch, seconded by Tracey, Council approve the closure of the two cases listed on Exhibit A. Approved unanimously.

### **Examining Committee**

Co-Chair Shine presented the report of the Examining Committee's meeting of February 29, 2012. Thirty-six (36) individual applications for licensure were reviewed and confidential recommendations made for Council action consisting of **31** applications for **comity**; **2** applications for individuals who meet all requirements but are currently not licensed in another jurisdiction; and **3** applications for **examination**. The Committee also reviewed **10** applications for **Certificate of Authorization**; and **11** requests for **Reinstatement**.

Motion by Shine, seconded by Robertson, Council approve the Committee's recommendations as shown on Exhibits A1 – A2 of the committee's report. Approved unanimously.

  - Motion by Gharebaghi, seconded by Crouch, DAPE advise DAFB of the lawful definition of the practice of engineering as per Section 2803 of the law to support the need for Delaware licensure. Approved unanimously.
