#### Minutes of the October 8, 2014 Council Meeting

Council reviewed the Minutes of the October 8, 2014 Council meeting. *Motion by C. Balascio, seconded by Hayden, Council approves the Minutes of the October 8, 2014 Council meeting as submitted.* Approved unanimously.

## D.A.G. Report

- Hearing scheduled for 10/10/14 in response to a Cease & Desist has been continued to explore settlement options.
- Surveying AG Opinion -- There is an exemption under the surveyor's law for engineers to practice surveying.

# **Committee Reports**

#### **Executive Committee**

The Executive Committee met just prior to the Council meeting, therefore, a written report is unavailable. Items discussed at Executive Committee meeting will be covered under the appropriate Committee reports.

## **Financial Report**

Finances for 50% of this fiscal year reflect income has reached 95% of projections; and expenses 36%.

Motion by Kooker, seconded by C. Balascio, Council approve the Financial report submit to audit. Approved unanimously.

## **Employee Benefits & Compensation** -- No report.

#### **Law Enforcement/Ethics Committee**

Chair Kooker presented the report of the committee's meeting on 11/5/14.

- Co-Chair Thomson is working on a draft <u>Memorandum of Understanding (MOU)</u> between DNREC and DAPE on the Class B designs.
- Sussex County engineer, Mike Izzo, has confirmed his vigilance on monitoring the <u>changing</u>, <u>altering or amending previously signed plans</u> to be in conformance with DAPE's position.
- Sussex County Design of Commercial Buildings: A DAPE member is requesting an interpretation of the law in the design of commercial buildings, as he has been advised that Sussex County requires an Architect to seal these plans. Sussex County building official, Andy Wright has confirmed that if it is architecture (according to the lawful definition) then an architect's seal will be required. Just as, if it is engineering, an engineer's seal will be required.

- Motion by Tracey, seconded by Retzlaff, Council approve the closure of the two cases listed on Exhibit A of its report. Approved unanimously.
- Motion by Kooker, seconded by Thomson, Council approve the Administrative Order in Case 14/082.
   Approved unanimously.

- Motion by Kooker, seconded by C. Balascio, Council approve issuing a subpoena in Case 13/109.
   Approved unanimously.
- <u>Case 14/090 (denial of licensure)</u> has requested a hearing. President Medlarz has appointed Chair Tracey, and Hearing Panel members Barbato and Hayden to hear the case.

#### **Examining Committee**

The Council reviewed the report of the Examining Committee's meeting of October 29, 2014. Twenty-eight (28) individual applications for licensure were reviewed and confidential recommendations made for Council action consisting of **23** applications for **comity; 1** application for individual who is not licensed elsewhere but meets all the requirements for licensure; and **4** applications for examination. The Committee also reviewed **9** applications for **Certificate of Authorization**, and **1** application for Temporary Permit.

Motion by C. Balascio, seconded by Hayden, Council approve the Committee's recommendations as noted on Exhibits A1-A2 of the committee's report dated November 3, 2014. Approved unanimously.

Traffic engineer, B.J. Song, provided a presentation on traffic engineering and guidelines to assist the committee in the review of applications.
