MINUTES - MAY 10, 2023 COUNCIL MEETING

A meeting of the Council of the Delaware Association of Professional Engineers was held on Wednesday May 10, 2023 in hybrid format (at DAPE office and via Zoom).

The Roll call was taken and a quorum was declared.

Meeting was called to order at 3:05 PM.

Open Forum – No members of the public were present.

Minutes of the April 12, 2023 Council Meetings

Council reviewed the Minutes of the April 12, 2023 Council meeting.

Motion by C. McAllister, seconded by K. Maxson, to approve the minutes of the April 12, 2023 meeting. Approved unanimously.

D.A.G. Report – None.

Financial Reports

K. Maxson summarized DAPE's finances for the twelve months (100%) of fiscal year ending April 30, 2023, which reflect income has reached 101.2% of projections and expenses 92.3%.

Motion by K. Maxson, seconded by K. Tadler, Council accepts the Finance Report subject to audit. Approved unanimously.

Committee Reports

Executive Committee

The Executive Committee met just prior to the Council meeting, therefore, a written report is unavailable. Items discussed at Executive Committee meeting will be covered under the appropriate Committee reports.

Finance/Employee Compensation & Benefits Committee/Facilities Committee - No Report

Law Enforcement/Ethics Committee

C. McAllister reported that the committee met on May 3, 2023 and discussed the following:

- New DAG Kemba Lydia-Moore attended meeting.
- Feedback related to April 18, 2023 Ethics training:
 - o Incorporate more interactive elements such as polling questions.
 - o Recording will be available soon.
 - DAPE can send a link to Delaware building officials (with time stamps to designate the section related to Certificate of Authorization requirements)
 - DAPE previously published details of disciplinary action and a listing of COAs that were delinquent in newsletters. DAG Kelly noted that disciplinary action information for other licensing boards is available on the Division of Professional Regulation's website.

Legislative amendment: the committee received and discussed additional feedback from ACEC and DelDOT related to House Bill 129. DelDOT provided some feedback in writing but was not able to attend the meeting. Members of the LEE Committee agreed with some of the suggestions, but not all of them. After the LEE Committee meeting, DAPE's Lobbyist arranged a meeting with Representative Ronald Gray to determine next steps (M. Clendaniel, J. Jakubowski, and R. Smith attended). With the current legislative session ending June 30, Representative Gray was concerned that additional delays would prevent an amendment from getting passed this year. House Amendment to HB129 was presented to Council for approval. This Amendment will add the definition of "Misconduct" which had been inadvertently dropped from the bill, and remove the definition and language related to "Successor Engineer."

J. Jakubowski offered to attend the next LEE Committee meeting to discuss the Amendment and next steps so that DAPE can redraft an amendment by November 2023 for the 2024 legislative session. The June 14, 2023 Council meeting agenda will include the appointment of an Ad Hoc Committee chair and approval of committee members to continue to discuss the successor engineer language (including representatives from DelDOT and ACEC). M. Davis will let us know when the bill is on the agenda of the Joint Legislative Oversight and Sunset Committee so that DAPE representatives can attend and answer questions if needed (likely J. Jakubowski and C. Lingenfelder).

Motion by M. Lennon, seconded by D. Reinhold, Council agrees with the House Amendment as presented, and that Representative Gray should have the Amendment introduced. Approved unanimously.

Motion by C. McAllister, seconded by K. Maxson, Council approve the closure of 6 cases listed on Exhibit A1 of the committee report. Approved unanimously.

Examining Committee

K. Tadler reported that the Committee met on April 26, 2023 and discussed the following:

- Training for three new Committee member
- PE Application questions related to citizenship
- Plan to discuss CPC Guidelines at May 31 meeting
