MINUTES - June 12, 2024 COUNCIL MEETING

A meeting of the Council of the Delaware Association of Professional Engineers was held on Wednesday June 12, 2024 in hybrid format (at Hyatt House, Lewes DE and via Zoom).

Open Forum

Council reviewed the Minutes of the May 8, 2024 Council meeting.

Motion by K. Maxson, seconded by J. Hastings, to approve the minutes of the May 8, 2024. Approved unanimously.

Financial Reports

K. Maxson reported that finances for the 1 month (8.3%) of fiscal year ending April 30, 2025 reflect income has reached 15.1% of projections and expenses 9.4%.

Executive Committee

The Executive Committee met just prior to the Council meeting, therefore, a written report is unavailable. Items discussed at Executive Committee meeting will be covered under the appropriate Committee reports.

Finance/Employee Compensation & Benefits Committee/Facilities Committee

K. Maxson reported that the committee met on May 23, 2024 and discussed the following:

- Office Lease Renewal draft agreement. Committee recommends that DAPE Council approve the
 agreement with minor revisions as discussed. J. Wootten sent a draft to OTHA, and they have
 agreed verbally to the terms. J. Wootten will be sure we have warning prior to the kitchen floor
 being replaced, so we can move furniture/refrigerator.
- Job descriptions: updated to reflect current distribution of work, which changed a bit since 2019 due to remote work and new employee.
- Annual review template: customized for each employee based on their job description

Council discussed the amended lease agreement, but decided to postpone a vote on this until a representative from OMB can address Council. E. Kelly will suggest a few dates, and Council may schedule a meeting prior to July 10 if possible. DAPE lobbyist M. Davis will be invited.
