MINUTES - AUGUST 13, 2025 COUNCIL MEETING

A meeting of the Council of the Delaware Association of Professional Engineers was held on Wednesday August 13, 2025 in hybrid format (at DAPE office, New Castle, DE and via Zoom).

Minutes of the July 9, 2025 Council Meetings

Council reviewed the Minutes of the July 9, 2025 Council meeting.

Motion by M. Clendaniel, seconded by K. Tadler, to approve the minutes of the July 9, 2025 Council meeting. Approved unanimously.

D.A.G. Report

- HB 81 is awaiting the Governor's signature.
- DAG Naylor prepared a recommendation from the May 20 hearing; the Hearing Committee
 members suggested one edit related to the NCEES Enforcement Exchange. J. Wootten will send
 the final recommendation to the respondent and Council will be asked to vote to approve the
 recommendation at the September meeting.

Financial Reports

Finances for the 3 months (25%) of fiscal year ending April 30, 2026 reflect income has reached 8.7% of projections and expenses 22%. Once the audit is complete, income will include deferred income related to last year's PE's renewal. With that estimated number, income has reached 40.6% of projections. COA renewals began on August 4, so there will be a significant increase in income next month.

Motion by T. Tadler, seconded by M. Clendaniel, Council accepts the Finance Report subject to audit. Approved unanimously.
