

President's Message

As someone who was enjoying the first official week of summer and a new addition to the Jakubowski family, I took pause in my excitement on the morning of June 24, 2021 after seeing reports of the partial collapse of the Champlain Towers South condominium building in Surfside, Florida. As a professional engineer who has been involved in the design and construction of buildings, these tragic images, videos and interviews hit especially hard.

Although there is no way to rationalize the lives that were lost or the tragedy experienced by family members, this disaster will eventually help to save lives. After several months or years of investigations and litigation, future updates of regulations, codes, specifications and requirements will contribute to improvements in public welfare.

What can we do until these studies and changes are complete?

At this point, there are no allegations of unethical actions associated with collapse. However, I thought it was a good opportunity to remind our members of key aspects and expectations of the DAPE Code Ethics and the ways it encourages promoting responsible engineering and licensure.

As part of the Delaware Professional Engineers' Act authorized on July 7, 1972, and most recently amended on July 17, 2019, Section 2816 states that all DAPE applicants, members and holders of certificate of authorization must subscribe to and follow the Code of Ethics prepared by the DAPE Council. The most recent version of the Code of Ethics is available on the DAPE website, and a recently revised Code of Ethics "exam" is provided to new applicants.

"1. THE ENGINEER SHALL HOLD PARAMOUNT SAFEGUARDING LIFE, HEALTH AND PROPERTY AND PROMOTING THE PUBLIC WELFARE IN THE PERFORMANCE OF HIS PROFESSIONAL DUTIES."

This powerful statement, along with five other sections addressing competence, truthfulness, conflicts of interest, solicitation of employment, and lawfulness, are further detailed in the Code of Ethics. In addition to providing engineering services in a professional, legal, and ethical manner, promoting public welfare can also take different forms, such as:

- Running for a DAPE Council position. The nomination period is closed for the 2021 Council Elections, but in spring 2022 we'll be accepting nominations for three seats.
- Contributing to a DAPE Committee that assists with examinations, law enforcement/ethics, external affairs, government affairs, or public information.
- Submitting a complaint to DAPE about the practice of engineering without a license, plan stamping, providing services outside of an area of competence or other alleged violations of the Professional Engineers' Act or Code of Ethics.
- Suggesting topics to DAPE staff for continuing education seminars and panel discussions.
- Joining the National Society of Professional Engineers Delaware Chapter, who promotes the ethical and competent practice of engineering and advocates for licensure.
- Mentoring students and future engineers in math, science or other technical fields or volunteer with groups such as ACE Mentor Program of America, Math Counts, DelDOT Bridge Design Competition, and the University of Delaware.
- Celebrating and promoting <u>Professional Engineers Day August 4</u>, 2021!!!

Executive Director's Message

DAPE conducted a random audit of members to be sure they met their Continuing Professional Development requirements following the June 30,

renewal, I did learn some lessons in the process that I'd like to pass along as you document your hours for the current renewal cycle which runs from July 1, 2020 to June 30, 2022.

- Notify DAPE if your contact information changes. If you are selected for a random audit but we don't have current contact information, you may not receive our notice in time to comply with the audit.
- Several members were working remotely and had problems accessing certificates, which they kept in paper format in their office; others had moved to new jobs and had to take additional training because their documentation was left behind. Consider keeping an electronic copy of your CPC documentation. NCEES has a free CPC tracking service, so you always have access to your documentation.
- The DAPE CPC Log form is available here. It's a good way to track your hours as you go. We do accept spreadsheets in place of this log form, as long as the information is comparable.
- The more organized your documentation is, the faster your audit can be completed.
- While we accept up to 9 hours related to business or project management, you are not required to take any training in this category.

While July tends to be a quiet month at DAPE, I am happy to report that our staff is back in the office full-time and together (we've been rotating days in the office since March of 2020). We always welcome your calls/emails if you have questions about your CPC documentation and requirements (or any other member-related questions).

The DAPE Council election runs from June 15-July 15 each year. This year, while we have 3 open seats, each has one candidate running uncontested.

Legislative Update

DAPE hired Ned Davis Associates, Inc. in April 2021 to advocate on our behalf in the Delaware State Legislature. Most recently the firm's Principal/Owner Mary Davis helped DAPE get sponsorship for a proposed legislative amendment. This amendment had been originally proposed in 2020 but was stalled due to the pandemic. HB142 was passed by the House and Senate and is now awaiting the Governor's signature. Mary's firm will also help us stay informed on broader professional licensing issues and promote licensure of Professional Engineers in conjunction with our upcoming 50th anniversary.

DAPE would like to thank our now-retired lobbyist Frank Newton for his guidance with past legislative amendments. Frank first became affiliated with DAPE as our Governor-Appointed Council member from Kent County when he was appointed by Governor Ruth Ann Minner in January 2006, serving as Council President between 2008-2010. To date, Frank has been the only Council President that has NOT been a licensed Professional Engineer. Combining his knowledge of DAPE and the Delaware State Legislature, he served as the DAPE lobbyist after completing his term on our Council.
