Law Enforcement Matters

The PE's "Selfie": Self-reporting

"Do I have to?"

When it comes to self-reporting any disciplinary action taken against you as an engineer, is honesty really the best policy? According to both §2823 of the Delaware Professional Engineers' Act and the DAPE Code of Ethics, the answer is YES! Full disclosure is the law, and self-reporting helps licensed engineers avoid additional fines and censures from DAPE. So, let's review the self-reporting requirement to ensure we're all in compliance.

You must self-report disciplinary action

- 1. Within 60 days of the final order imposing discipline by the out-of-state engineer licensing board;
- 2. At the time of application to DAPE for a new Professional Engineering license;
- 3. At the time of renewal of your Delaware Professional Engineering license if you haven't already reported it.

In fact, the PE renewal questions are intended to guide you to full disclosure:

- Have you been a subject of disciplinary action by the licensing authority in another jurisdiction?
- Have you been convicted or entered a plea of guilty or nolo contendere of any crime (other than traffic violations) since your last renewal?

If you delegate the process of your PE renewal to someone else, remember that **you as the licensee** are still responsible to answer the renewal questions truthfully to avoid the appearance of deception regarding disciplinary action.

"They'll never know, right?"

Since October 2018, DAPE has been checking monthly Enforcement Exchange listings against the active PE roster to verify that any disciplinary action taken has been self-reported to DAPE within 60 days. The statistics are surprising: in the last four years, approximately 90 licensees have been identified as having disciplinary action (1.9 per month), with 12 licensees identified since June 2022 (2.4 per month).

Engineers who fail to self-report within 60 days may become the subject of further investigation by DAPE's Law Enforcement and Ethics Committee. Depending on the number and scope of the violations, a licensee may receive administrative penalties that could range from a warning letter up to revocation of the license.

"Yikes! How can I come clean?"

If you have unreported disciplinary action taken against you in an out-of-state jurisdiction, your best next step is to self-report it immediately to DAPE's Executive Director, office@dape.org so your licensing file is correct and current.

When it comes to self-reporting, let's work together to maintain a high level of integrity for our Association and our profession.

Code of Ethics Amendment

DAPE's Law Enforcement & Ethics Committee recommended an amendment to the Code of Ethics which was approved by Council in August 2022. The amendment was a change to the wording of the very last paragraph. Here is the new language:

C. The engineer, upon conviction for any felony crime not specifically listed in Canon 6.A, shall provide within ninety (90) days of conviction, information to the Council in sufficient specificity to enable Council to make a determination of whether the crime constitutes conduct reasonably likely to deceive, defraud, or harm the public.

The Code of Ethics is binding on all DAPE applicants and registrants. As such, it's a good idea to review this document periodically. You can find DAPE's Code of Ethics

Random CPC Audit - January 2023

Now that we are through the 2022 PE and Certificate of Authorization renewal seasons, DAPE will be conducting a random CPC audit of approximately 250 members. Notices will go out in January, but don't wait to be sure your documentation is in order. Current CPC Guidelines can be found here. Be sure to refer to the "Recordkeeping" section on pages 3-4 when reviewing your documentation.

NCEES Mechanical PAKS

NCEES is currently seeking licensed mechanical engineers to participate in a professional activities and knowledge study, or PAKS, for the PE Mechanical exams. The results of this online survey will be used to update the content of the PE exam, which is used throughout the United States.

PE Mechanical exams include Heating Ventilation Air Conditioning and Refrigeration (HVAC), Machine Design and Materials (MDM), and Thermal and Fluid Systems (TFS). NCEES is also considering the addition of a Plumbing Engineering exam to the Mechanical suite of exams. If you are a licensed professional engineer, we would appreciate your input by completing an online survey.


NCEES requires a cross section of licensed professional engineers practicing mechanical engineering—including those working in industry, consulting, the public sector, and academia—to complete the online survey in order to update exam content and specifications. The survey will help determine the knowledge and skills required of a licensed mechanical engineer with four to six years of experience to practice in a

These studies help NCEES ensure its licensing exams remain relevant to current professional practice," explained Chief Officer of Examinations Jason J. Gamble, P.E. "The value of this PAKS depends on the number of people who participate, so NCEES is eager to get a large response from P.E.s across all areas of mechanical engineering."
