PRESIDENT'S MESSAGE

In my previous message, I talked about the importance of ethics for Engineers and called for renewed zeal in championing the importance of our profession. I intended to delve deeper into the Code of Ethics with this message today. However, after

recently attending the NCEES northeast and southern zone meeting, where almost half of the US Engineering boards were present, my focus has shifted to new concerns.

Our Professional Engineering licenses are under attack. Multiple state licensing boards have faced challenges from legislators in regard to the need for engineering licensure. Most believe that the nexus of this movement is the 2015 Supreme Court Ruling regarding the North Carolina Board of Dental Examiners. In this ruling the Dental Board was in to be restraining free trade in their field, which they regulated as members of that profession. Following this ruling, several State Engineering Boards were challenged on the same basis by anti-trust focused legislators, under the cloak of job creation and economic development. In Montana, a bill was proposed to eliminate the licensing board for engineers. In Arkansas, Minnesota and Iowa, bills were proposed to provide the "right to engage in lawful occupation free from regulation", which follows this disturbing political trend to attack licensure as a barrier to employment. To date, none of these attempts have succeeded.

These attacks appear to often commingle groups of licenses such as barbers, cosmetologists, and Engineers, as if they are all just a simple license that impedes free trade. We as Engineers should clearly see how our profession is unique in that we protect public health,

safety, and welfare. The test is easy – if you have a dire medical need, would you accept someone other than an M.D., and if you have a critical legal issue, would you want to be defended by someone other than a licensed attorney? Both professions also protect public health and welfare. Despite this, we still see erosion to the Engineer title, even to the extent of some local employers courting and placing non-engineers (determined by education, experience and examination) into Engineering job titles.

My call to you now as Professional Engineers in this State is to carry yourself professionally and ethically, stay abreast of this critical topic, challenge those who speak out against Engineering licensure, and push for the continued recognition of the PE license as the defining qualification for practice. It is only through this license that we can guarantee the trust and protection of the public, as we have done since our first license in 1907.

EXECUTIVE DIRECTOR'S MESSAGE

We've been busy tackling many issues since our last issue of the newsletter. We are proposing some legislative revisions and hope to have these endorsed by the legislature in the next few weeks. Changes include:

- Reducing the number of years a license may remain "Inactive" from 10 years to 4 years (or two renewal cycles).
- Requiring an application for licensure concurrently when a temporary permit application is submitted.
- ✓ Indicating that electronic signatures and date are permissible.
- Clarified that a licensee who voluntarily surrenders a license in order to avoid disciplinary action by other jurisdictions can be disciplined.

The rationale for these proposed revisions is to clarify the existing law and to update provisions with streamlined practices. Much discussion and several rewrites of the proposed legislation were involved in getting to this point. Whether electronic signatures should be encrypted and to what level of encryption is something still under discussion, however, since the current law was silent on the issue of electronic signature, but addressed electronic seals, we felt compelled to at least indicate that signing electronically is permissible.

In our previous issue of the newsletter we discussed our Rule to Show Cause hearings for those 25 licensees that did not respond to our request for an audit of their Continued Professional Competency (CPC) activities. As a result of these hearings, several licenses were reinstated with admonishment that responses are required. Some licenses were suspended until we were able to verify that the CPC requirements were met. And, several licenses were revoked for not meeting the CPC requirements for the renewal of the license. These are disciplinary matters that are reportable to the national database requiring licensees to report to their other states We have discussed these cases further of licensure. under our "Law Enforcement Corner" section of this newsletter.

This first renewal cycle implementing CPC was a learning experience for DAPE Council and staff as well as our membership. We trust that we have all learned from this experience and look forward to future streamlined audits, knowing that our licensees will attempt to renew timely and also provide adequate documentation to support any claimed activities.

Recently, DAPE co-hosted the NCEES Northeast/Southern Zone joint meeting in St. Thomas, Virgin Islands. Several representatives of the DAPE board were in attendance to hear the NCEES officer and committee reports from the many working committees on education, examinations, finances, law enforcement, bylaws and technology task force. There was an election for zone officers and a discussion on a proposed resolution to increase the votes for those states that have dual boards. Currently Delaware gets two votes – one for each of its separate surveyors and engineers boards. California with its dual board (engineers/surveyors) gets one vote. This resolution was not favored. I'm sure additional discussion will continue at the Annual meeting.

The renewal period for firms' Certificates of Authorization is open. All Certificates will expire on June 30, 2017 if not renewed by that time. Renewal is simple. Log in to www.dape.org - Certificates of Authorization - license renewal to update the firm information, provide appropriate signatures and documentation.

It is unlawful to offer or provide engineering services in Delaware without the appropriate authorization. Unlicensed practice is a serious violation. Renew your firm's authority today!

The credentials of all candidates will be available for review when the balloting period opens on June 15th. Your vote does count. You'll be advised electronically to log in and cast your vote.

There is also a proposed revision to the bylaws to increase the PE application fee. This is necessitated by a procedural change by NCEES that now requires all exam fees be paid directly to them in preparation for all exams going to computer-based testing. Currently only the Chemical Engineering exam is computer-based, which means we will continue to administer the other exams. This increase is to partially offset the expenses of exam administration. Council supports this increase in fees.

The burden of proof remains with the licensee in the Rule to Show Cause hearing process. Licensees were required to either provide the appropriate documentation or appear for the disciplinary hearing before our 3-member Hearing Panel and present their case. One of our licensees travelled from Saudi Arabia to attend his hearing because of the value he placed on his license.

These disciplinary matters have all been reported to the national enforcement database and licensees are required to report these actions to any other states in which they are licensed.


